Rates quoted are exclusive of GST. Fees will be charged on a Unit cost plus GST basis.

The fees quoted above are current at the time of printing. Fees are reviewed quarterly and clients are encouraged to obtain a current copy of the Schedule of Fees at the time of enquiry.

Cancellation Policy: Services cancelled or declined with less than 24 hours notice will be charged at the cost of the scheduled service, unless the cancellation is due to an emergency/hospitalisation.

General Consumables: Where general consumables are supplied as part of a service, a general consumable charge will be incurred in line with the above rates. Consumable charges will be discussed as part of the Care Planning and Assessment process.

Clinical Consumables: Corumbene reserves the right to recover the cost of clinical consumables in association with any services provided.

Travel Costs: Corumbene reserves the right to on-charge any travel related costs incurred in the provision of the services. Travel costs will be on-charged as cost plus 20% administration fee.

Sleepover Rates: 12 hour sleepover rate includes 4 hours of service and an 8 hour sleep period. Two 30 minute assistance calls are included in the 8 hour sleep period. Cumulative assistance calls greater than 1 hour will be charged at the hourly rate.

Dispersed Services: Appointments and service scheduling will be made in the best interest of clients. Where possible appointments will be clustered to best utilise time for service staff. Where a client requires a service or appointment that cannot be delivered as part of a bundle to either the client or clients within close proximity, the service may incur an additional fee in line with the dispersion levels identified above. Clients will be advised in advance whether dispersion levels are to be charged.

Assessments: Assessments are required by law and are conducted upon commencement of service then half yearly (L2) and quarterly (L4) or as legislated. Should an assessment be required outside of this cycle, it will be charged at the applicable rate where the travel required is less than a 25km radius of Corumbene. Any assessments outside of the 25km radius will incur travel costs at \$1.00 per km.

Minimum Duration/Unit: The minimum duration/unit is typically 1 hr, however an application can be made in writing to Corumbene where extenuating circumstances exist. If approved a negotiated package of 30 minute duration/unit may be applied at a rate of 75% of the typical hourly rate. The written applications will be reviewed on a case by case basis and where applications are declined Corumbene are not obliged to provide justification.

Exit Amount: An exit amount is a charge that a provider can deduct from a client's unspent home care package funds if the client leaves their care (either because the client decides to change to another home care provider, or the client leaves home care). The exit amount is intended to allow providers to recover administrative costs associated with determining and making payment of unspent home care amounts.
